3.0 ELIGIBILITY REQUIREMENTS

- II. Evidence of Certificate of Incorporation issued by Corporate Affairs Commission **(CAC)**.
- III. Tax Clearance Certificate **(TCC)** for the last three (3) years (2023, 2024& 2025), valid till December 31st 2026.
- IV. Evidence of current Industrial Training Fund **(ITF)** Compliance Certificate valid till 31/12/2026.
- V. Evidence of current Nigerian Social Insurance Trust Fund **(NSITF)** Compliance Certificate valid till 31/12/2026.
- VI. Evidence of current National Pension Commission Certificates valid till December 31st, 2026
- VII. Evidence of registration on the National Database for Contractors, Consultants, and Service providers or an Interim Registration Report issued by BPP or a valid certificate issued by the Bureau of Public Procurement **(BPP)**. **Valid till December 2026**
- VIII. List of key personnel with evidence of qualification, experience, and professional registration in relevant areas, with their CVs.
- IX. List and evidence of similar past jobs in the last (3) years with completion certificates.

X. Verifiable affidavit disclosing whether or not any officer of the relevant committees of the Independent Corrupt Practices and Other Related Offences Commission or the Bureau of Public Procurement is a former or present Director, Shareholder, or has any pecuniary interest in the bidder, and to confirm that all information presented in its bid is true and correct in all particulars;

XI. Evidence of financial capability to execute the project by submission of an original reference letter from a reputable commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed

XII . The Company's Audited Accounts for the last three (3) years (2023, 2024 & 2025), signed and sealed by the FIRS, Auditors, and the Directors.
