Confirmation of receipt of payment

This is to bring to the attention of the Honourable Chairman my confirmation that I have on the 9th January 2015 received the payment in respect of my reimbursement for my medical costs which have been outstanding since 1995 which the commission has been assisting me to recover from the FMT.

I wholeheartedly express my immense gratitude to the Chairman, the Head of Financial Investigation (Kayode) and his assistant (Gbega Ogunlana) they have worked tirelessly in exerting maximum pressure on FMT without letting them any breathing space which resulted in the eventual release of this payment.

I am convinced beyond reasonable doubt that without the intervention and maximum application of the Commission's authority FMT would never have made this payment which has been pending for 20 years this January. In fact they blocked any possibility of making the payment and would not entertain nor respond to any of my communications over the years on the matter and taking the route of due process of the law was not practically possible for me due to my circumstance.

For your information I am highly qualified and experienced to be able to assist the Commission both here and abroad; I studied at the University of Lagos and my Thesis was 'WAR against indiscipline' which I deliberately chose to look at the Buhari / Idigbon Administration Programme at the time which I chose to test the effect of that Federal Government programme at the time (the life and behaviours of citizens). I also have a Post Graduate in Journalism from TJI; since being in the UK I have obtained a Law degree and trained in the BAR but was not called to the BAR of England and Wales. I also have a degree in International Relations and Politics and Applied Social Sciences all from the UK. With my wealth of experience and exposure I have what it takes to help Nigeria drive the Country forward if called upon to do so.
